Hereby undertake approve and consent to be bound by the practice of the Weizmann Institute of Science (hereinafter: “**the Institute**”) relating to inventions and discoveries (collectively: “**inventions**”) and undertake to act in accordance to the Institute Rules for Intellectual Property and Conflict of Interests² (hereinafter: “**the Rules**”) as follows:

1. All rights in the intellectual property, (including inventions, patents, copyrights, samples, breeders rights, trademarks and confidential information) which I shall create, either by myself or together with others, while being a student at the Feinberg Graduate School (hereinafter: “**Feinberg**”) and/or in consequence of my participation in a research executed in the Institute, whether registered or not, including any work, innovation, development, notion, technology, work methods, processes, research data, electronic rights, report, plan, specification, sketch, program and/or any other right whatsoever (hereinafter: “**the Property**”) shall be in the full and absolute proprietorship of the Institute or Yeda Research & Development Company Ltd. (hereinafter: “**Yeda**”). I shall not have any right of any kind and type whatsoever in the Property and the Institute or Yeda shall be entitled to make any use and/or disposition thereof, according to their sole and absolute discretion, including the registration of the rights in the Property in their favor.
2. I shall report to the Vice President of Technology Transfer of the Institute (hereinafter: “**the Vice President**”) and also to Yeda, about any kind of Property which I will conceive, within the process or in consequence of my activity, as stated.
3. I undertake to take any action necessary in order to transfer and/or register the Property in favor of the Institute or Yeda and/or in order to assure their proprietary interest, in Israel or overseas, during my studies at Feinberg and/or my participation in a research executed in the Institute and thereafter.
4. As a student, studying at Feinberg and/or as a participant in a research executed in the Institute, I agree to keep the confidentiality of any inventions, which I will conceive and/or will be brought to my attention, during or within the framework of my studies at Feinberg and/or my participation in a research executed in the Institute and in of any applicability of such research.
5. In the event that Yeda shall actually receive any consideration (either monetary or money equivalent) (hereinafter: “**the Receipts**”) in accordance with an agreement with a third party (with the exception of service agreements) Yeda shall transfer to the inventors of such invention, which is subject to an agreement as stated, a certain part of these Receipts, after deduction of Yeda’s expenses. The cumulative share of the inventors from the Receipts is determined according to the policy of the Institute at such time. I have been informed and I agree that in the event of more than one inventor, the share of each of the inventors shall be determined in agreement between them. In the absence of an agreement between the inventors, the share of each of the inventor shall be determined according to the process, specified in the Rules.
6. Without prejudice to the generality of that stated above, I hereby confirm that I read the Rules and I accept its contents and the Rules, which will be in force from time to time, shall apply to me and be binding upon me for each and every purpose, and I am obligated to act according to it. Furthermore, I approve that I do not have any other commitment whatsoever, which is in contradiction with my aforementioned obligations or such that prevents me from meeting my said obligations.
7. Confidentiality – General

- a. Without derogating from article 4 above, I hereby acknowledge that in the course of my studies at the Feinberg and/or my participation in a research executed in the Weizmann Institute of Science I shall have access to confidential and proprietary information, both of the Institute and of third parties disclosed under NDAs, grant agreements etc. Confidential Information may include data, materials, products, technology, computer programs, software, specifications, manuals, scientific information of any kind - including but not limited to scientific protocols and work plans, scientific results, financial information, and other information disclosed or submitted, orally, in writing, or by any other media, to me by the Institute or by anyone among the Institute's staff during the course of my studies at the Feinberg and/or my participation in a research (hereinafter: "Confidential Information").
- b. I hereby agree that the Confidential Information is to be considered confidential and proprietary to the Institute, or to a third party who has provided such Confidential Information under confidence and I shall hold the same in strict confidence, take all measures in order to prevent the distribution and exposure of the Confidential Information or to prevent it from leaking out and it reaching anyone that is not authorized to do so.
- c. The provisions of this Confidentiality Undertaking are not limited in time and I shall be bound by them even after the term or termination of my studies at Feinberg and/or my participation in a research executed in the Institute.
